This may also be noted to bring your original Identity Card alongwith a copy of it. If, you are not coming on the date fixed and, ^{five} the application shall automatically stand rejected.

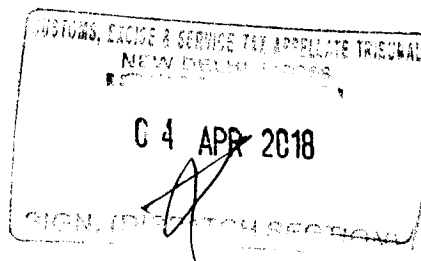
