CIRCULAR

Sub: Biometric Attendance System in CESTAT.

It has been noticed that not all regional Benches of CESTAT has installed Biometric Attendance System for marking attendance and to ensure punctuality. Complaints have been received from the public that the office staff are regularly coming late and leaving the office before the closure of office hours. Rule 3 (1) (ii) of CCS (Conduct) Rules, 1964 mandates that every government servant shall at all times maintain devotion to duty. Habitual late attendance is viewed as conduct unbecoming of a government servant and disciplinary action may be taken against such a government servant. Hence it is informed that punctuality in attendance, not to mention remaining in office during office hours and not to leave before office hours, is to be observed by all officers. Accordingly, Hon'ble President has directed that all officers and staff from the level of deputy registrar shall register in the biometric portal and mark their attendance. Steps are already taken to install uniform biometric machines in all regional Benches where they are not already installed and it is the responsibility of the Head of Office to make it operational and maintain it with periodical review of its functioning including its storage. The software may be installed in the system of the Head of Office and the officer who is immediately supervising the registry. The free software "Time Viewer" shall be downloaded and this will enable the head quarter to review the attendance. A compliance report may be sent to the undersigned within a month's time.


